OFFICER REPORTS

Treasurer:

As of September 30, 2021, checking account balance \$152,883.

Gwen reported that she has fully reconciled the VENMO account and reports the following findings:

** The SPC board previously voted not to be responsible for the Bistro, which was a project taken on without board authorization. An analysis of the Sunrise Pickleball Club Venmo account shows that there were payments made for Bistro transactions directly from the SPC bank account and deposits were also received from Venmo. Although the deposits don't fully reach the amount due to SPC by approximately \$900, it is unclear if Paypal transactions or direct deposits may account for this difference. Due to the pandemic and an extended period without a treasurer, records are incomplete.

** MOTION** Gwen motioned to continue to move forward and close the Venmo account, which had been held open during reconciliation.
